[Regarding Pretrial Deadlines for Bellwether Trial No. 12, Jury Selection Matters, Scheduling of the Final Pretrial Conference, And Application of Certain Pretrial Orders in MDL Bellwether Trial Nos. 1, 2, 5, 7, and 9 to MDL Bellwether Trial No. 12 (*McKnight*)]<sup>1</sup>

1. **Courtroom**: Bellwether Trial No. 12 will begin on **Monday, January 28, 2019**.

The Court plans to hold the trial in Courtroom 1105 of the Thurgood Marshall United States

Courthouse. As with past trials, the parties should contact the District Executive's Office as trial

approaches to see if "war rooms" in the Courthouse can be provided.

2. **Pretrial Deadlines**: The following schedule and the chart at the end of this Order

summarize all upcoming pretrial deadlines for Bellwether Trial No. 12:

a. Amended Complaint: Plaintiff filed an Amended Complaint on Tuesday,

August 14, 2018. New GM filed an Answer on Tuesday, September 18, 2018.

b. **Dispositive** *McKnight* **Motions**: Dispositive motions will be due on **Tuesday**,

November 6, 2018. Responses will be due on Wednesday December 5, 2018, and replies will be

due on Wednesday, December 19, 2018. Unless the Court orders otherwise, memoranda shall

The reason for the delay was the Court's consideration (for reasons unrelated to this case) of whether to change the trial to begin on **Tuesday, January 22, 2019**. The Court is still considering whether to make that change (in which case some of the deadlines, particularly those closer to the trial date, would be modified accordingly) — and will advise the parties as soon as possible one way or another. In the meantime, no later than **October 2, 2018**, the parties shall file letters advising the Court if there is any unavoidable conflict that would prevent them from beginning trial on January 22, 2019.

comply with the page limits and other requirements set forth in this Court's Local Rules, except that reply briefs shall not exceed 15 double-spaced pages.

c. **OSI Disputes**: In accordance with the Court's guidance in Order No. 86 Section XV (Docket No. 1772) and at the February 23, 2016 Status Conference, plaintiff shall disclose her proposed OSIs and file her supporting brief by **Friday October 5, 2018**. Any response from New GM will be due on **Friday, October 19, 2018**. The parties' respective briefs shall not exceed 35 double-spaced pages. Plaintiff shall file her reply brief, not to exceed ten double-spaced pages, by **Friday, October 26, 2018**.

d. Motions *in Limine*: The parties shall file all motions *in limine*, not to exceed 15 double-spaced pages per opening brief, by no later than Friday, November 9, 2018. Responses, not to exceed 15 double-spaced pages per brief, will be due on Tuesday, November 20, 2018, and replies, not to exceed five double-spaced pages, will be due on Friday November 30, 2018.

e. *Daubert* Motions: Omnibus *Daubert* motions, not to exceed 50 doublespaced pages per brief, will be due on **Tuesday**, **November 6**, **2018**. Responses, not to exceed 50 double-spaced pages per brief, are due **Wednesday**, **December 5th**. Replies, not to exceed 20 double-spaced pages per brief, are due **Wednesday**, **December 19**, **2018**.

f. **Joint Pretrial Order**: The parties shall submit their joint proposed pretrial order (consistent with the Court's Individual Rules and Practices for Civil Cases, except to the extent modified herein) by no later than **Friday, January 11, 2019**.

g. Witness Lists: By no later than Friday, December 14, 2018, the parties shall disclose their respective good faith lists of all witnesses whom they may potentially call at trial ("Initial Witness List"). The parties will not be permitted to call a witness not included on the Initial Witness List, absent extraordinary circumstances. By no later than Friday, January 11, 2019, the parties shall make available for deposition any witness from their Initial Witness List who has not previously been deposed in this matter. The parties will disclose their respective good faith lists of witnesses whom they intend to call at trial ("Will Call Witness List") and their respective good faith lists of additional witnesses whom they may call at trial ("May Call Witness List") as part of the Joint Proposed Pre-Trial Order due January 11, 2019.

h. Exhibit Lists: Trial exhibit lists must be exchanged no later than Friday, December 14, 2018. Branded copies of the parties' trial exhibits must be exchanged by no later than Friday, January 4, 2019. The parties may by mutual agreement add or subtract additional trial exhibits at any time after. Each party may add up to 20 exhibits to its exhibit list by Wednesday, January 9, 2019 without a showing of good cause or mutual agreement ("Free Exhibits"). Copies of all exhibits shall be submitted to the Court by Tuesday, January 22, 2019. Finally, stipulations regarding authenticity and non-hearsay of exhibits are due on Friday, January 11, 2019.

Disclosure of Valukas Report and Statement of Fact Excerpts: Plaintiff
will disclose the Valukas Report and Statement of Facts excerpts she intends to use at trial
by Friday, December 28, 2018. Any disputes shall be submitted to the Court by
Wednesday, January 9, 2019.

j. **Deposition Designations**: Each party shall submit deposition designations by no later than **Friday**, **December 21**, **2018**. Counter-designations and objections to the original designations shall be submitted by no later than **Wednesday**, **January 15**, **2019**. Letter briefs regarding categorical objections to deposition designation and counterdesignations and objections to counter-designations shall be submitted by no later than **Friday**, **January 18**, **2019**.

k. **Stipulations of Law and Fact**: The parties are encouraged to enter into stipulations of law and fact, if any, by **Friday, January 11, 2019**.

1. **Proposed Jury Questionnaire**: The parties shall exchange a proposed summary of the case, a list of names, and any proposed modifications to the questionnaires used in Bellwether No. 1 by no later than **Friday, December 7, 2018**. Jury questionnaire disputes, along with the parties' proposed questionnaires, shall be submitted to the Court by no later than **Friday, December 14, 2018**.

m. **Proposed Jury Instructions and Verdict Form**: Proposed jury instructions and a proposed verdict form, whether a joint proposal or competing proposals, must be exchanged by no later than **Friday**, **December 14**, **2018**. Jury instruction and verdict form disputes, along with the parties' proposed instructions and verdict forms, shall be submitted to the Court by no later than **Wednesday**, **January 9**, **2019**. As with previous Bellwether Trials, the parties need not submit proposed language for standard and/or introductory instructions (on the role of the jury, burden of proof, etc.).

n. **Demonstrative Aides**: The parties shall exchange demonstrative aides reasonably anticipated to be used during opening statements (that is, anything that a party proposes to show the jury, whether it is likely to come into evidence or otherwise) by no

later than **Tuesday**, **January 22**, **2019**, at **2:00 p.m. EDT** and shall raise any objections by **Tuesday**, **January 22**, **2019**, at **10:00 p.m. EDT**. Any dispute shall be submitted to the Court by no later than **Thursday**, **January 24**, **2019**, at **7:00 p.m. EDT**.

3. **Final Pretrial Conference**: The Court will hold the Final Pretrial Conference in Courtroom 1105 of the Thurgood Marshall Courthouse on **Wednesday**, **January 23**, **2019** at **9:00 a.m.** (taking a break, as needed, to address the prospective jurors in connection with the written questionnaire discussed below). At the final pretrial conference, the parties should be prepared to discuss, among other things, how much time each side should be allocated at trial.

4. Jury Selection: In light of the Court's experience with jury selection in the earlier Bellwether Trials, it intends to summon fewer jurors for Bellwether Trial No. 12 — a venire of approximately 65 members. With one minor modification discussed below, the Court will use the same jury selection procedures for Bellwether Trial No. 12 that it used for Bellwether Trial No. 1. (See Docket No. 1380.) In accordance with those procedures, written jury questionnaires will be completed by prospective jurors on Wednesday, January 23, 2019, and the parties will have until Friday, January 25, 2019 at 10:00 a.m. EDT, to review the questionnaires and to submit a list of jurors that both sides agree should be excused for cause. At that same time, the parties shall also submit a list of jurors that only one party believes should be excused for cause (with a brief explanation of the basis for such belief). The Court will review the parties various lists and will decide which, if any, of those jurors should be excused for cause. The Court will then conduct oral *voir dire* of the remaining prospective jurors on Monday, January 28, 2019, beginning at 9:30 a.m. EDT.

5. **Extensions**: Given that **Monday**, **January 28**, **2019**, is (subject to the caveat in the footnote above) a firm trial date, the Court is unlikely to grant any extensions of the foregoing dates and deadlines absent extraordinary circumstances or confidence that the extension

would have no effect on the trial date. The parties may also by agreement extend deadlines provided that any such extensions would have no effect on the trial date. In accordance with the Court's Individual Rules and Practices for Civil Cases, any request for an extension shall be filed as a letter motion on ECF.

6. **Application of Certain Pretrial Orders in Bellwether Trial Nos. 1, 2, 5, 7 and 9 to Bellwether Trial No. 12:** The parties will submit a joint show cause proposal and any competing letter briefs regarding the applicability of certain non-exhibit and non-deposition designation pretrial rulings (including the Court's rulings on motions *in limine*) from Bellwether Trial Nos. 1, 2, 5, 7 and 9 by **Friday, November 16, 2017.** 

7. Effect of This Order on Other Rules and Orders: To the extent not explicitly modified herein, the Court's Individual Rules and Practices in Civil Cases and Rules and Procedures for Trials and all other applicable Orders of this Court remain in full force and effect. The Court may enter additional and/or modified orders regarding the pretrial schedule of Bellwether Trial No. 12 as circumstances require.

8. **Summary of Pretrial Deadlines**: For ease of reference, the chart attached as Exhibit 1 to this Order summarizes all of the pretrial deadlines set forth above for Bellwether Trial No. 12. If any party should later move to amend any of these deadlines, that party shall submit as part of the letter motion requesting the extension a revised version of this chart with the proposed amendments.
