AGREED AMENDED ORDER REGARDING THE PRESERVATION OF IGNITION SWITCH PARTS GOVERNED BY NHTSA RECALL CAMPAIGN 14v-047000

I. Introduction

General Motors LLC ("New GM") and Plaintiffs, through Lead Counsel, jointly submit this Agreed Amended Preservation Order for approval and entry by the Court. This Amended Preservation Order supersedes the preservation provisions in the August 11, 2014 Agreed Order Regarding the Preservation of Ignition Switch Parts Governed by NHTSA Recall Campaign 14v-047000 (Docket No. 35), and modifies New GM's obligations for maintaining and preserving recalled ignition switch parts covered by National Highway Traffic Safety Administration ("NHTSA") Recall Campaign 14v-047000.

II. Background

1. On August 11, 2014, this Court entered the Agreed Order Regarding the Preservation of Ignition Switch Parts Governed by NHTSA Recall Campaign 14v-047000 ("Agreed Preservation Order"), which sets forth New GM's obligations for maintaining and preserving recalled ignition switch parts covered by NHTSA Recall Campaign 14v-047000. (Docket No. 35, at 1.)

2. The Agreed Preservation Order provided that "[a]s of July 23, 2014, New GM had received, or was in the process of receiving, ignition switch parts from more than 400,000 vehicles

affected by NHTSA Recall Campaign 14v-047000." (*Id.* ¶ 9.) The Agreed Preservation Order further provided that "[a]ll parties reserve the right to request a modification of this Order, including seeking an order further limiting New GM's preservation obligations with respect to the preserved vehicle ignition switch parts." (*Id.* ¶ 17.)

III. Protocol for Continuing Preservation of Ignition Switch Parts

3. New GM has represented that it will be subject to undue burden and incur unnecessary costs if the company continues to store all the recalled ignition switch parts covered under NHTSA Recall Campaign 14v-047000 that are the subject of the Agreed Preservation Order. Plaintiffs are amenable to modifying New GM's obligations so long as Plaintiffs are in no way prejudiced. The Parties agree that it is appropriate for the Court to enter preservation orders that properly balance the right of Plaintiffs to obtain relevant evidence against the potential undue burden and expense to New GM of preserving large numbers of parts that have been the subject of recalls.

4. For good cause shown, the Court orders the following with respect to New GM's obligations to continue preserving ignition switch parts covered by NHTSA Recall Campaign 14v-047000 that are the subject of the Agreed Preservation Order.

A. Switch Parts Associated with Named Plaintiffs

5. New GM shall undertake reasonable efforts to assist any named plaintiff in a case that has been transferred to MDL 2543 (or pending in another venue) with preserving ignition switch parts covered by NHTSA Recall Campaign 14v-047000 that may be relevant to the plaintiff's claims. To allow New GM to do so, before a recall repair is performed, a named plaintiff (or his or her counsel) must provide both the dealership replacing the ignition switch parts and New GM with reasonable, advance notice that the plaintiff wishes to have parts preserved for

purposes of litigation. New GM will then use reasonable efforts to arrange for the dealership making the repair to return the ignition switch parts to New GM for storage and preservation.

B. Ongoing Preservation of Sample of Other Switch Parts

6. New GM is only obligated to preserve and must continue preserving the following number of recalled ignition switch parts covered under NHTSA Recall Campaign 14v-047000 that are the subject of the Agreed Preservation Order:

The Parties agree that preservation of these parts will result in New GM preserving a representative sample of ignition switch parts covered by NHTSA Recall Campaign 14v-047000, and New GM may not argue otherwise for any purpose in litigation.

7. Subject to paragraph 5, New GM is not required to preserve ignition switch parts covered by NHTSA Recall Campaign 14v-047000 over and above the number of parts identified in paragraph 6. New GM may now dispose of and shall not further preserve any ignition switch parts not identified in paragraph 6.

8. This Order shall also apply to related cases later filed in, removed to, or transferred to this Court.

9. All parties reserve the right to request a modification of this Order, including seeking an order further limiting New GM's preservation obligations with respect to the preserved vehicle ignition switch parts.
